

NYSMHS Western District Schooling Dressage Show

Tests are the current USDF and USEF tests; USEF dressage rules apply. Riders may be limited to two (2) tests per horse, if the entries warrant. Tests will be ridden in a large arena (60 x 20 meters); the footing is stone dust/sand. Readers are permitted. **It is the responsibility of the competitors to indicate on their ENTRY FORM which test they will be riding in the Choice of Classes 10 & 11.**

Awards: Ribbons through sixth place. Four Championship Awards: Introductory Level, Training Level, First Level and Second Level and above. The Championships for Introductory Level, Training Level and First Level will be awarded based on the average of two scores in that Level. The Second Level and Above Championship will be awarded based on the average of any two scores at the same level with the following adjustments: Second Level (no adjustment), Third Level (plus 3%), and Fourth Level (plus 5%). These adjustments are made to recognize that it is more difficult for a horse competing at a higher level to attain a given score than a horse competing at a lower level.

Entries close May 1, 2017. Times will be available no later than **May 23, 2017.** Times will be posted in the Show Office and e-mailed to competitors who provide e-mail addresses on their entry forms. Times may also be obtained by calling.

The **Western Dressage Championship** will be awarded based on the average of any two scores at the same level with the following adjustments: Introductory (no adjustment), Basic (plus 3%), Level 1 (plus 5%) and Level 2 (plus 7%). These adjustments are made to recognize that it is more difficult for a horse competing at a higher level to attain a given score than for a horse competing at a lower level.

Directions to grounds:

From the Thruway (I-90)
Coming from Amherst, Rochester, Syracuse, or Pennsylvania – Take exit 56 (Blasdell/Milestrip). Make a left onto Milestrip Road (Route 179). At the second light, make a right hand turn on to McKinley Parkway. The fairgrounds and Showplex are on your right immediately after Quinby Street.

Health Requirements:

All horses entering the show must have a negative Coggins certificate (EIA). New York State horses must have a Coggins certificate for 2016 or 2017. Out of state horses and Canadian horses must have a Coggins certificate within 12 months. All out of state horses are required to have a health certificate dated within 30 days. Proof of Rabies vaccination must be presented for all horses. In addition, all horses over seven (7) months of age must have proof of Equine Influenza Virus and Equine Herpes Virus (Rhinopneumonitis) vaccinations within 6 months of entering the show grounds.

Footing:

Stone dust and sand, outdoor footing. We will be using large arena. There are indoor warm-up arenas on the grounds.

Stabling:

Portable box stalls with full doors in enclosed barns available Friday-Sunday. If stabling is required for any time outside of Friday-Sunday, stall fees for the WNY Morgan show will apply (\$110 for Tuesday-Sunday). Stabling will be assigned & info will be available at show office.

Management Notes:

Management reserves the right to cancel or combine classes as necessary.

Rides may be limited if needed and will be based on time of receipt of entries.

There will be no refunds for scratches. Credit will be given toward post entries in other classes. Entry fees will be refunded upon request before May 15, 2017. After this date, fees will be refunded upon receipt of a veterinarian's certificate. A bona fide casualty to an exhibitor or exhibitor's family member is eligible. There will be a **\$15 office charge** on all refunds. **Stall fees will not be refunded.**

Exhibitors are notified that any act of discourtesy or disobedience to the Judge, Officials, or Management, on the part of the owner, rider, trainer or groom shall disqualify the horse and rider and the owner shall forfeit entrance and other fees.

There will be an On Call Veterinarian available and a Farrier available on the grounds.

Refreshments will be available along with other vendors.

RELEASE FORM
